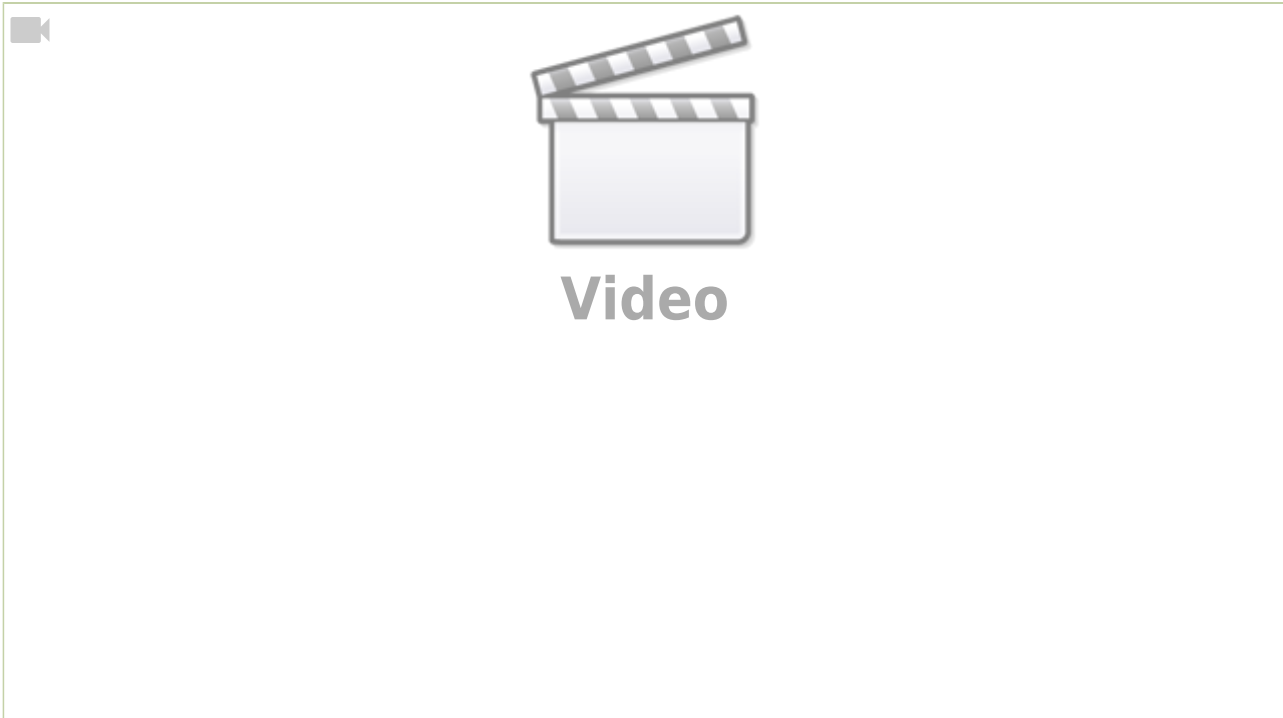

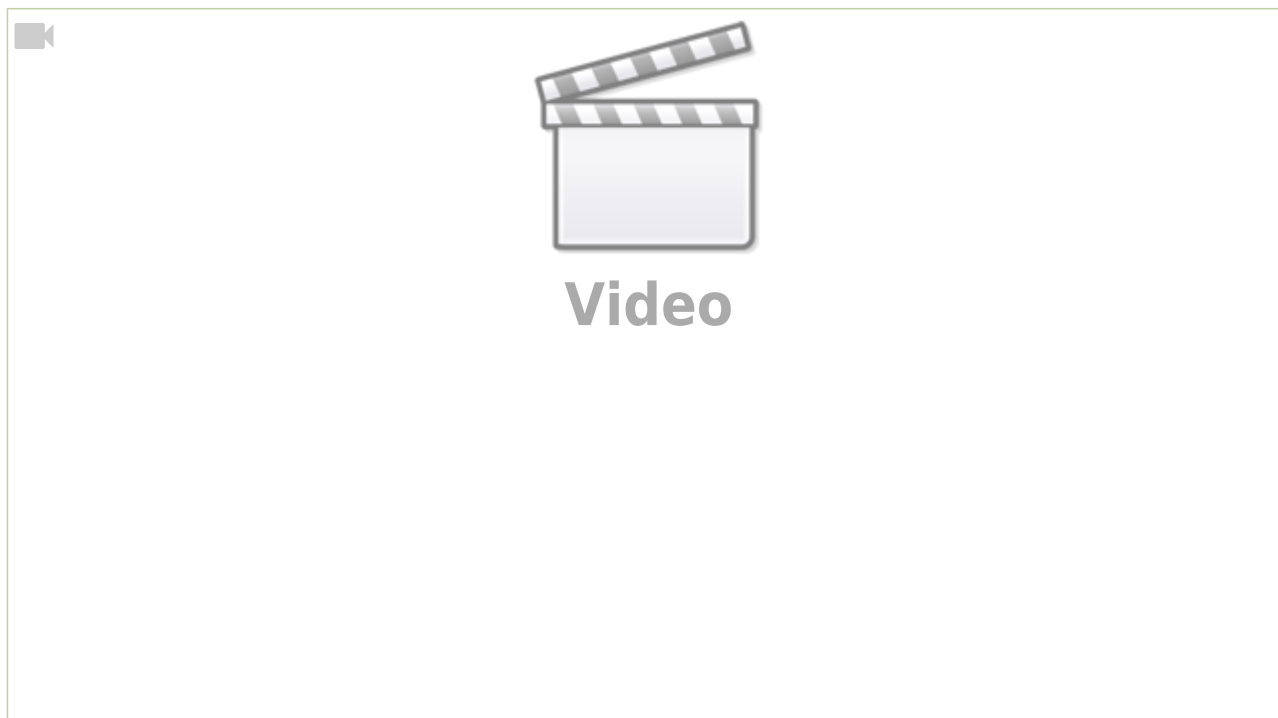

<b>Details</b>	<p><b>When students use Plickers cards:</b></p> <ul style="list-style-type: none"> <li>• We collect nothing but the answers they submit in response to multiple-choice questions.</li> <li>• The Plickers app processes images locally and immediately discards them, so images are not transmitted, collected, or stored in any way.</li> </ul> <p><b>When students use <a href="https://my.plickers.com">my.plickers.com</a>:</b></p> <ul style="list-style-type: none"> <li>• When a student enters their unique code into Plickers, we send the code to our server and use it to associate the student's device with the correct student record in your class.</li> <li>• We collect only: <ul style="list-style-type: none"> <li>◦ Unique student code</li> <li>◦ IP address</li> <li>◦ Session token</li> <li>◦ Online status/presence</li> <li>◦ Basic usage data</li> <li>◦ Referrer information</li> <li>◦ User-Agent information</li> <li>◦ Answers submitted in response to multiple-choice questions</li> </ul> </li> </ul> <p><b>Policy Statements:</b></p> <hr/> <p><b>1. 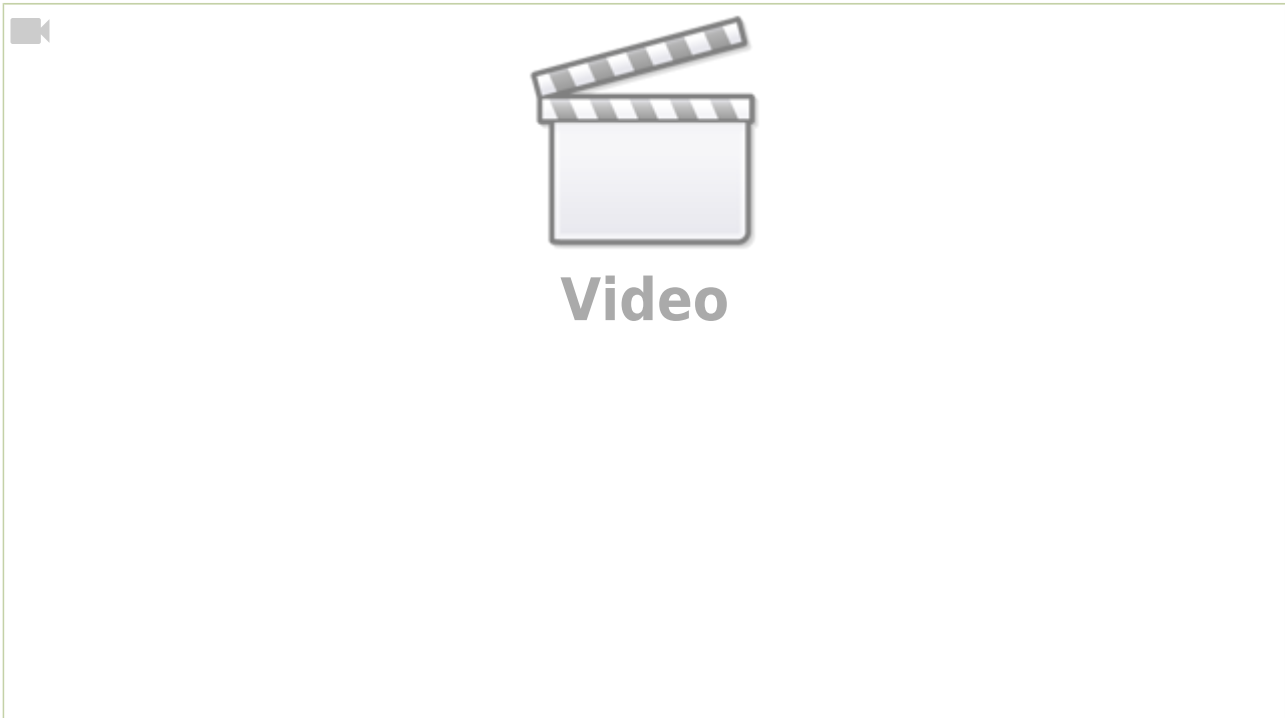
